## THE ORDINANCE FOR THE AWARD OF FOUR YEARS BACHELOR OF DESIGN (B.DES.)

## 85.1- Title of the Degree

B.Des. (Bachelor of Design)

## 85.2- Specializations / Branch

- 1) Fashion Design.
- 2) Textile Design.
- 3) Accessory Design.
- 4) Interior Design.
- 5) Fashion Communication.
- 6) Apparel Production.

## 85.3- Course & Faculty

- 85.2.1- This ordinance shall be applicable to the Bachelor of Design (abbreviated B.Des.) an undergraduate or bachelor degree in Design of Four years duration. This course shall be run on annual pattern system.
- 85.2.2- This course shall be run by the Faculty of Fashion & Animation.

#### 85.4- Duration

85.3.1- The Duration of the Degree of Bachelor of Design (B.Des.) shall comprise a course of study spread over a period of four academic years and candidate will have to be a full time student.

## 85.5- Branch/Specialization Distribution

**85.4.1-** Admission to the particular branch/Specialization of study shall be as decided by the University on the basis of counselling/ personal interview.

#### 85.6- Intake & Fees

- **85.5.1-** The intake shall be decided by the Board of Management of the University. Multiple classes can be setup as per the approval granted from the respective authority.
- 85.5.2- The fees of the courses shall be decided by the Board of Management of the University from time to time subject to the approval of the regulatory body, if any.

#### 85.7- Eligibility

- 85.6.1- Candidates who have passed duly recognized following examination:-
  - 85.6.1.1- Final examination of the 10+2 system by any recognized Central Board, such as Central Board of Secondary Education, New Delhi, and Council for Indian School Certificate Examination, New Delhi or any State Board such as M.P. Board of Secondary Education Bhopal or Others.

OR

85.6.1.2- H.S.C. Vocational Examination by any recognized Central/State Board

OR

85.6.1.3- Senior Secondary School Examination conducted by the National/any State Open schooling with a minimum of five subjects of relevant and required fields.

OR

85.6.1.4- Any Public School/ Board /University examination in India or in any foreign country recognized as equivalent to 10+2

OR

85.6.1.5- Final Examination of the two year course of the Joint Services Wing of the National Defence Academy

OR

85.6.1.6- Any other examination equivalent to 10+2 by Central/State Government OR

85.6.1.7- Candidates who have passed 10th and 3 or 4 years diploma recognised by AICTE or a State Board of Technical Education.

AND

85.6.1.8- Candidate should have passed in all the subjects with minimum requirement, as prescribed by the UGC/other concerned Regulatory Bodies.

Note: Candidate who is appearing or has appeared for any qualifying examination during the current academic session as a regular or a private candidate can also apply for admission on provisional basis, subject to the condition that the candidate must pass the qualifying examination with require percentage of marks or equivalent grade.

85.6.2- Eligibility for Admission to NRI /other privileged Candidates:

85.6.2.1- Non-resident Indian and other privileged candidate shall be eligible for admission to these courses in accordance with the directives of Govt. of India and/or State Government.

85.7.1.1- Passed Secondary School Examination/10th

OR

85.7.1.2- Passed Senior Secondary Examination/12th recognized by AIU.

OR

85.7.1.3- Passed 3 or 4-years diploma related to Fashion / Apparel / Textile and Accessories / Home Science/ Handloom Technology / Products / Visual Communication / Graphic Design / Industrial Design / Interior Design / Multimedia Design / Apparel Technology / Leather from institutions recognized by the AICTE/AIU/UGC or a State Board of Technical Education.

OR

85.7.1.4- Must have passed any UG Degree from an university recognized by the university grants commission with a minimum 45% marks.

#### 85.9- Admission Procedure

- 85.8.1- Admission under this courses will be made as follows:
  - 85.8.1.1- The University will Issue admission notifications in news-papers, on the University's website, notice board of the university and in other publicity media before the start of every cycle.
  - 85.8.1.2- List of candidates provisionally selected for admission /shortlisted based on merit/ Entrance Examination marks will be displayed on the notice board of the University/ University's website or the students will be informed directly of their admission after the last date of application.

- 85.8.1.3- The candidates whose results of the qualifying exam are awaited can also apply who will be admitted provisionally. Such candidates, however, must produce the previous year mark sheet/School/College certificates as a proof for required eligibility criteria before the due date failing which the provisional admission cannot be granted. The candidate so admitted shall have to be present mark sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.
- 85.8.1.4- If a candidate admitted provisionally could not obtain the marks to fulfill the requirements & eligibility criteria of the admission the provisional admission granted to him will be cancelled.
- 85.8.1.5- The application form may be rejected due to any of the following reasons:
  - The candidate does not fulfil the eligibility conditions
  - The prescribed fees are not enclosed.
  - The application form is not signed by the candidate and his/her parent guardian, wherever required.
  - Supporting documents for admission are not enclosed.
- 85.8.1.6- Enrolment / Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
- 85.8.1.7- Admission rules as framed by the University shall be applicable for all admissions from time to time.

#### 85.10- Academic Cycle/Year

85.9.1- There will be one academic cycle for these courses every year as decided by the University/Department.

#### 85.11- Medium of Instructions and Examinations

85.10.1- The medium of instructions and examinations shall be either Hindi or English.

#### 85.12- Attendance Requirement:

85.11.1- A candidate must have at least 75% attendance. Provided that in case of illness or because of other reasonable cause it shall be relaxed by the Vice Chancellor as admissible within applicable regulations.

#### 85.13- Course Structure

- 85.12.1- The B.Des. course in annual pattern shall consist of:
  - a) Such courses (papers) as prescribed by the University.
  - b) Such job assignments, internship, projects etc. as may be prescribed by the University/Department.
  - c) Such scheme of examination as prescribed by the University/Department from time to time.
  - d) It will also include co-curricular and extra-curricular activities as prescribed from time to time by the university/Department.
- 85.12.2- The course curriculum of the course shall be approved by the concerned Board of Studies and the Academic council of the University. The Academic council of the University on the recommendation of the concerned Board of Studies may change number of papers and / or marking scheme of the course after the due approval of Vice chancellor.

#### 85.14-Examination Scheme

85.13.1- No candidate shall be allowed to take the Examination unless one has:

- a) Attended at least 75% of lectures / practical delivered.
- b) Paid all the fees due

- c) Obtained 'No Dues' certificate from the concerned Department/college.
- d) Submitted the job internship certificate / Project Report as notified by the Director/Head/ Principal.
- e) Received in-plant training as prescribed by the Director/ Head/ Principal. Clause (a) above shall not be applicable to Ex-student candidates

#### 85.15-Allocation of Division

- 85.14.1- Division shall be awarded only after the fourth and final year examination, based on integrated performance of the candidate for all the four years. The Division shall be awarded on the basis of Marks obtained in Internal Assessment and University examination (Theory and Practical Both) taken together.
  - a) If candidate passes all examinations in single attempt and secures 75% or more in aggregate marks he/she shall be placed in the First Division with Honors.
  - b) If candidate passes all examinations and secures aggregate marks of 60% or more but less than 75% OR greater than or equal to 75% after back in any examination, he/she shall be placed in First Division.
  - c) If candidate passes all examinations and secures aggregate marks of 50% or more but less than 60%, he/she shall be placed in Second Division.
  - d) Kulpati Grace of one mark will be given for Pass/ATKT In each semester and for improvement in division in final semester.

Note:-(i) No third division shall be awarded.

85.16.1- A candidate has to complete the entire programme of under graduate degree within a maximum period of Eight years from the session of his/her first admission in the concern programme.

#### 85.18- Examination Centres

85.17.1- The Entrance Examination and the Semester/Annual term examination centre(s) will be notified by the university.

#### 85.19- General

- **85.18.1-** The admission to the Courses shall be governed in accordance and provisions with the Rules/Directives of UGC/ relevant Regulatory Body or any other competent Authority of the Govt. of India/ State Government as amended time to time.
- 85.18.2- In matters of admission, attendance, examinations and in all other matters not provided in this ordinance, the courses shall be governed by the provisions of the relevant ordinances of the same in the University so far as they are not inconsistent with the provisions of this ordinance.
- 85.18.3- In case of any dispute/ambiguity, the ruling of the Vice Chancellor shall be final. However on the recommendations of the Academic Council the Vice-Chancellor shall be competent to change the System/Pattern of the examination.
- 85.18.4- The above course shall run on all possible modes of imparting education including the use of latest innovative technologies like- on-line, e-learning, face-to-face, through webinar etc.

- 85.18.8- In case of any dispute the matter shall be decided under the Jurisdiction of District Court, Chhatarpur M.P.
- 85.18.9- Reservation of seats for SC/ST/OBC as per the Norms.

This Ordinance shall be applicable to B.Des. & all others four years Bachelor Degree in specialized streams of Fashion Designing & Technology, except those for which the University has separate Ordinances. The courses mentioned in this ordinance shall run under this ordinance.

87.6.1.3- The candidates whose results of the qualifying exam are awaited can also apply who will be admitted provisionally. Such candidates, however, must produce the previous year mark sheet/School/College certificates as a proof for required eligibility criteria before the due date failing which the provisional admission cannot be granted. The candidate so admitted shall have to be present mark sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.

- 87.6.1.4- If a candidate admitted provisionally could not obtain the marks to fulfil the requirements & eligibility criteria of the admission the provisional admission granted to him will be cancelled.
- 87.6.1.5- The application form may be rejected due to any of the following reasons:
  - a. The candidate does not fulfil the eligibility conditions
  - b. The prescribed fees are not enclosed.
  - c. The application form is not signed by the candidate and his/her parent guardian, wherever required.
  - d. Supporting documents for admission are not enclosed.
- 87.6.1.6- Enrolment / Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
- 87.6.1.7- Admission rules as framed by the University shall be applicable for all admissions from time to time.

## 87.7- Academic Cycle/Year

87.7.1- There will be one / two academic cycle for these courses every year like summer & winter as decided by the University/Department.

## 87.8- Medium of Instructions and Examinations

87.8.1- The medium of instructions and examinations shall be English.

## 87.9- Attendance Requirement:

87.9.1- A candidate must have at least 75% attendance. Provided that in case of illness or because of other reasonable cause it shall be relaxed by the Vice Chancellor as admissible within applicable regulations.

#### 87.10- Course Structure

  - d) Submitted the job internship certificate / Project Report as notified by the Director/Head/ Principal.
  - e) Received in-plant training as prescribed by the Director/ Head/ Principal. Clause (a) above shall not be applicable to Ex-student candidates

87.12- Allocation of Division

- 87.12.1- Division shall be awarded only after the second and final year (Fourth Semester) examination, based on integrated performance of the candidate for all the two years (4 Semester). The Division shall be awarded on the basis of Marks obtained in Internal Assessment and University examination (Theory and Practical Both) taken together.
- 87.12.2- If candidate passes all examinations in single attempt and secures 75% or more in aggregate marks he/she shall be placed in the First Division with Honours.
- 87.12.3- If candidate passes all examinations and secures aggregate marks of 60% or more but less than 75% OR greater than or equal to 75% after back in any examination, he/she shall be placed in First Division.

87.12.4- If candidate passes all examinations and secures aggregate marks of 50% or more but

less than 60%, he/she shall be placed in Second Division.

87.12.5- Kulpati Grace of one mark will be given for Pass/ATKT In each semester and for improvement in division in final semester.

Note:-(i) No third division shall be awarded.

87.13- Merit Lists

87.13.1- Merit list of first 10 candidates in the order of merit shall be declared at the end of the last i.e. fourth semester (second year) from amongst the candidates who have cleared their all respective semester/annual examination, including internal assessment uninterrupted at a stretch without any back/drop/break etc

87.14- Maximum Duration of Completion of Course

87.14.1- A candidate has to complete the entire programme of post graduate degree within a maximum period of Four years from the session of his/her first admission in the concern programme.

87.15- Examination Centres

87.15.1- The Entrance Examination and the Semester/Annual term examination center(s) will be notified by the university.

87.16- General

- 87.16.4- The above course shall run on all possible modes of imparting education including the use of latest innovative technologies like- on-line, e-learning, face-to-face, through webinar etc.
- 87.16.5- This programme is offered by the Faculty of Management recommended by the concerned Board of Studies and after approval of Academic Council and Board of Management of the University.

87.16.6- In future, more branches/ specializations/ courses/ programmes of can also be offered, keeping in view of new innovations, thrust areas of Government policies and demand of the industry/ society shall run under this ordinance, on the recommendations of the concerned Board of Studies from time to time, by the University, in its various faculties/ departments/ centres/ institutes located in University campus.

87.16.7- The University shall also offer more number of two years Master's degree programmes with the various specialization titles under this ordinance on the recommendation of concerned Board of Studies, of University alone and/or in collaboration with or tie-up with other Educational or Academic Institutes/ Organizations/ Universities/ Research Organizations/ Industries and to provide the dissemination of Knowledge to all concerned throughout the World.

87.16.8- In case of any dispute the matter shall be decided under the Jurisdiction of District

Court, Chhatarpur M.P.

87.16.9- Reservation of seats for SC/ST/OBC as per the Norms.

This Ordinance shall be applicable to M.F.M.& all others two years (4 Semester)Master's Degree in specialized streams of Fashion Designing & Technology, Fashion Management except those for which the University has separate Ordinances. The courses mentioned in this ordinance shall run under this ordinance.

THE ORDINANCE FOR THE AWARD OF TWO YEARS (4 Semester) POST GRADUATE DIPLOMA IN MANAGEMENT (PGDM)

## 88.1- Title of the Degree

PGDM(Post Graduate Diploma in Management)

#### 88.2- Course & Faculty

- 88.2.1-This ordinance shall be applicable to the Post Graduate Diploma in Management (abbreviated PGDM) of two years (4 Semester) duration. This course shall be run on Semester pattern system.
- 88.2.2- This course shall be run by the Faculty of Management.

#### 88.3- Duration

88.3.1- The Duration of the Post Graduate Diploma in Management (PGDM) shall comprise a course of study spread over a period of two academic years (4 Semester) and candidate will have to be a full time student.

### 88.4- Intake & Fees

88.4.1- The intake shall be decided by the Board of Management of the University. Multiple classes can be setup as per the approval granted from the respective authority.

88.4.2- The fees of the courses shall be decided by the Board of Management of the University from time to time subject to the approval of the regulatory body, if any.

88.5- Eligibility

88.5.1- Candidates who have passed duly recognized following examination:-

88.5.1.1- Candidate should be a graduate in any discipline with at least 50% (45% for reserved categories) marks in aggregate or equivalent grade from any Indian University or foreign University or Institute recognized by the University as equivalent or any Open University. However, the graduate degree should be with minimum three years study after passing (10+2) class examination of (10+2) scheme or equivalent (10+2+3) year system or any equivalent examination.

OR

88.5.1.2- The candidate should possess professional/Technical Degree in any field like Engineering, Technology, Information Technology, Medical Science, veterinary Science, Agriculture Science, Pharmacy, Law etc. with at least 50% (45% for reserved categories) marks in aggregate or equivalent grade from any Indian University or foreign University or Institute recognized by the University as equivalent.

OR

88.5.1.3- Associate membership of any professional bodies which is recognized by the University as equivalent to any UG or PG Degree with at least 50% (45% for reserved categories) marks in aggregate or equivalent grade.

Note: However, candidate who is appearing or has appeared for final year/semester of any degree/qualifying examination during the current academic session as a regular or a private candidate can also apply for admission on provisional basis, subject to the condition that the candidate must pass the qualifying examination with require percentage of marks or equivalent grade.

88.5.2- Eligibility for Admission to NRI /other privileged Candidates:

88.5.2.1- Non-resident Indian and other privileged candidate shall be eligible for admission to these courses in accordance with the directives of Govt. of India and/or State Government.

88.6- Admission Procedure

88.6.1- Admission under this courses will be made as follows:

88.6.1.1- The eligible candidates as specified in clause (88.5) above, should secure a place in the merit list prepared on the basis of academic credentials or through the University entrance test/Examination consisting of Aptitude Test/ Group Discussion, Personal Interview or through Counselling or the University may also use the score card of various competitive entrance test/ examination results of various Institute/Board/University/other Professional Bodies/ Organizations or any other mode as decided by the AICTE/UGC/other relevant Regulatory Bodies from time to time or based on qualifying exam.

88.7- Specialization Distribution

88.7.1- Admission to a particular stream/ specialization of PGDM Course/ Programmed shall be as decided by the University on the basis of either merit or counselling or personal interviews.

88.8- Academic Cycle/Year

88.8.1- There will be one / two academic cycle for these courses every year like summer & winter as decided by the University/Department.

88.9- Medium of Instructions and Examinations

88.9.1- The medium of instructions and examinations shall be English.

88.10- Attendance Requirement:

A candidate must have at least 75% attendance. Provided that in case of illness or 88.10.1because of other reasonable cause it shall be relaxed by the Vice Chancellor as admissible within applicable regulations.

## 88.11- Course Structure

The PGDM course in semester pattern shall consist of: 88.11.1-

a) Such courses (papers) as prescribed by the University.

b) Such job assignments, internship, projects etc. as may be prescribed by the University/Department.

c) Such scheme of examination as prescribed by the University/Department from time to time.

d) It will also include co-curricular and extra-curricular activities as prescribed from time to

time by the university/Department.

The course curriculum of the course shall be approved by the concerned Board of 88.11.2-Studies and the Academic council of the University. The Academic council of the University on the recommendation of the concerned Board of Studies may change number of papers and / or marking scheme of the course after the due approval of Vice chancellor.

## 88.12- Examination Scheme

- No candidate shall be allowed to take the Examination unless one has:

shall not be applicable to Ex-student candidates

Successfully acquired the minimum required credits as specified in the 88.13.1.2regulation corresponding to the branch of his/her study within the stipulated time, where ever

88.13.1.3- Earned the specified credits in all the subjects' if applicable.

- 88.13.1.4- Secured a minimum CGPA of 5.0 or 50% in aggregate or equivalent Grade overall. However the award of the Division/ Class shall be as per recommendation of concerned Board of Studies of the University.
- 88.13.1.5- No dues to the University, Hostels, Libraries, NCC/NSS etc. and

88.13.1.6- No disciplinary action is pending against him/her.

88.14- Allocation of Division

88.14.1- Division shall be awarded only after the second and final year (Fourth Semester) examination, based on integrated performance of the candidate for all the two years (4 Semester). #### 89.1- Purpose-

89.1.1- The approval of the Academic council, Executive council and the General Council of the Shri Krishna University, Chhatarpur M.P. it will implement One Year LL.M. Degree Programme from the academic session i.e. 2019-20.

## 89.2- Course & Faculty -

89.2.1-This ordinance shall be applicable to the Masters of LAW (abbreviated LL.M.) an postgraduate or master's degree in LAW of One years (2 Semester) duration. This course shall be run on Semester pattern system.

89.2.2- This course shall be run by the Faculty of LAW.

## 89.3- Duration -

89.3.1- The Duration of the Degree of Masters of law (LL.M.) shall comprise a course of study spread over a period of one academic year (Two Semester) and candidate will have to be a full time student.

## 89.4- *Intake & Fees* -

**89.4.1-** The intake shall be decided by the Board of Management of the University. Multiple classes can be setup as per the approval granted from the respective authority.

89.4.2- The fees of the courses shall be decided by the Board of Management of the University from time to time subject to the approval of the regulatory body, if any.

## 89.5- Academic Cycle/Year -

89.5.1- There will be one/two academic cycle for these courses every year, one from July to June and Second from January to December or as decided by the University/Department.

## 89.6- Admission & Eligibility -

- 89.6.1- The candidates seeking admission to the one year LL.M. Degree course must passed the Bachelors of Law (LL.B.) or any other equivalent qualifications as approved by BCI with at-least 55% of marks (in-case of ST/SC candidate 50% of the marks LL.B. or equivalent Examination)
- 89.6.2-Candidate appearing for the final semester of LL.B. Examination and awaiting for their result can apply. They will have to provide proof of passing the examination within 30 days of admission.
- 89.6.3-If a candidate admitted provisionally could not obtain the marks to fulfil the requirements & eligibility criteria of the admission the provisional admission granted to him will be cancelled.
- 89.6.4- The application form may be rejected due to any of the following reasons:
  - The candidate does not fulfil the eligibility conditions
  - The prescribed fees are not enclosed.
  - The application form is not signed by the candidate and his/her parent guardian, wherever required.
  - Supporting documents for admission are not enclosed.
- 89.6.5-Enrolment / Registration number will be assigned to the student by the University after verification & submission of all the necessary documents/fees.
- 89.6.6-Admission rules as framed by the University shall be applicable for all admissions from time to time.

## 89.7- Admission Procedure-

89.7.1- Admission under this courses will be made as follows:

89.7.1.1- The University will Issue admission notifications in news-papers, on the University's website, notice board of the university and in other publicity media before the start of every cycle.

89.7.1.2-ist of candidates provisionally selected for admission /shortlisted based on merit/ Entrance Examination marks will be displayed on the notice board of the University/ University's website or the students will be informed directly of their admission after the last

date of application.

89.7.1.3- The candidates whose results of the qualifying exam are awaited can also apply who will be admitted provisionally. Such candidates, however, must produce the previous year mark sheet/School/College certificates as a proof for required eligibility criteria before the due date failing which the provisional admission cannot be granted. The candidate so admitted shall have to be present mark sheet of the qualifying examination within a month of the due date of admission, failing which the provisional admission shall be cancelled.

## 89.8- Course Structure -

89.8.1- The LL.M. course in semester system shall consist of:

a) Such courses (papers) as prescribed by the University.

b) Such job assignments, internship, moot court, project etc. as may be prescribed by the University and

c) Such scheme of examination as prescribed by the University from time to time.

89.8.2- The course curriculum of the course shall be approved by the concerned Board of Studies and the Academic council of the University. The Academic council of the University on the recommendation of the concerned Board of Studies may change number of papers and / or marking scheme of the course after the due approval of Vice chancellor.

89.8.3- Each semester course shall be conducted in not less than 18 weeks with not less than 30 class hours per week including tutorial, moot court, and seminars provided there shall be at least 24 lectures hours per week.

Note – Optional / Specialization papers – University offering specialized LL.M. degree shall offer courses in one or more of the groups of the specialization. Each group of specialization shall consist of several papers from which the students can choose the number required to get the degree of that specialization.

## 89.9- Medium of Instructions and Examinations-

89.9.1- The medium of instructions and examinations shall be either Hindi or English.

## 89.10- Attendance Requirement-

89.10.1- A candidate must have at least 75% attendance. Provided that in case of illness or because of other reasonable cause it shall be relaxed by the Vice Chancellor as admissible within applicable regulations.

## 89.11- Examination Scheme-

- 89.11.1- No candidate shall be allowed to take the term-end Semester Examination unless one has:
  - a) Attended at least 75% of lectures / practical delivered.
  - b) Paid all the fees due
  - c) Obtained 'No Dues' certificate from the concerned Department/college.
  - d) Submitted the job internship certificate / Project Report as notified by the Director/ Head/ Principal.

- e) Received in-plant training as prescribed by the Director/ Head/ Principal. Clause (a) above shall not be applicable to Ex-student candidate.
- 89.11.2- Each student shall have to appear in the examination of theory/practical and continuous comprehensive examination system (CCE)/ internal assessment. The internal assessment will be held in the manner prescribed from time to time by the university.
  - a) 30% marks of each paper will be earmarked for internal assessment (for each semester, there will be two separate evaluations of 15 marks each)
  - b) Main examination will carry 70% marks.
  - c) For passing the examination, the candidate that be required to secure at least 40% marks in university examination separately in the term-end theory, practical and internal assessment in each of the prescribed paper and aggregate of 50% in the subject (sum of theory and practical marks)
  - d) There will be an external examiner to evaluate the project report. The minimum passing marks for project work will be 50%.

## 89.12- Promotion to next semester -

- 89.12.1- From First to Second Semester —A candidate shall who has appeared in the first semester (Theory and Practical) examination shall be promoted to second semester of the year, irrespectively of falling in any number of theory paper and practical examination of that semester.
- 89.12.2- Ex-Studentship —Subject to the general rule of promotion from First Semester to Second Semester a candidate shall become ex-student if he/she could not get success in any of the paper of either semester irrespectively of failing in any number of theory and practical / project examination.

## 89.13- Allocation of Division -

- 89.13.1- Division shall be awarded only after the second and final semester examination, based on integrated performance of the candidate for all the two semester. The division shall be awarded on the basis of marks obtained in internal assessment of university examination (Theory and Practical both) taken to-gather.
- 89.13.2- In order to declare successful at any of the LL.M. Semester examination every candidates will have to obtain at-least 40% marks in individual papers and at-least 50% marks in aggregate
  - (a) Those who obtain 60% or more marks: First Division
  - (b) Those who obtain 50% or more but less than 60% marks: Second Division
  - (c) Candidates who pass both Parts at the first attempt and with minimum duration of the course after obtaining 75% or more marks of the total aggregate shall be declared to have passed with "Distinction".

#### \*No Third Division shall be awarded

A candidate who has been declared unsuccessful at a semester examination may at his/her option reappear at it subsequently as ex-student without being required to attend regular course of study again for the same semester subject to the condition that such a candidate shall abide by and shall be governed by provision of this and other ordinances as applicable.

The Executive Council shall publish the results of the examination as soon as possible for it.

## 89.14- Merit Lists -

89.14.1- Merit list of first 10 candidates in the order of merit shall be declared at the end of the last i.e. Second semester from amongst the candidates who have passed all previous semesters in one attempt.

## 89.15- Maximum Duration of Completion of Course -

89.15.1- A candidate has to complete the entire course of LL.M. within a maximum period of TWO years from the session of first admission.

## 89.16- General-

- 89.16.1- In matters of admission, attendance, examinations and in all other matters not provided in this ordinance, the courses shall be governed by the provisions of the relevant ordinances of the same in the University so far as they are not inconsistent with the provisions of this ordinance.
- 89.16.2- In case of any dispute/ambiguity, the ruling of the Vice Chancellor shall be final. However on the recommendations of the Academic Council the Vice-Chancellor shall be competent to change the System/Pattern of the examination.

99.1- Title of the Course

Degree in Occupational Therapy (4.5 Years)

99.2- Course & Faculty

99.2.1-This ordinance shall be applicable to candidates appearing for Bachelor Degree in Occupational Therapy of 4 ½ years(Four Academic years and six month internship) duration. This course shall be run on Semester pattern system. After successful completion of IV year, the student shall require to complete six months compulsory internship programme.

99.2.2- All courses shall be run by the Faculty of Health Science and Department of Paramedical.

99.3- Duration

99.3.1-The Duration of the Bachelor Degree in Occupational Therapy shall comprise a course of study spread over a period of 4 ½ academic years (4 academic year and six month internship) and candidate will have to be a full time student.

99.4- Intake & Fees

99.4.1-The intake shall be decided by the Board of Management of the University/MP Paramedical Council. Multiple classes can be setup as per the approval granted from the respective authority.

99.4.2- The fees of the courses shall be decided by the Board of Management of the University

from time to time subject to the approval of the regulatory body, if any.

99.5- Eligibility

99.5.1-Candidates who have passed duly recognized following examination:-

- 100.13.6- In future, more branches / specializations / courses / programmes of Degree can also be offered, keeping in view of new innovations, thrust areas of Government policies and demand of the industry / society shall run under this ordinance, on

The recommendations of the concerned Board of Studies, from time to time, by the University, in its various Faculty / School I Centers I Institutes located in University campus.

# SHRI KRISHNA UNIVERSITY, CHHATARPUR(M.P.) ORDINANCE NO.- 101 of 2019

THE ORDINANCE FOR ADMISSION OF INTERNATIONAL STUDENTS

#### 101.1- INTERNATIONAL AFFAIRS

Shri Krishna University in compliance after the approval of the competent authority agreed in principle to open admissions to International Students. The intake of International Students shall start from the coming Academic Session 2019-2020. The University has created a separate entity to look after the matters related to admissions of International Students in terms of procedure, process, admission, and related administration. This new entity of the University is INTERNATIONAL AFFAIRS headed by Director. The University has planned to provide accommodation to all the International Students.

101.1.1- Applicants seeking admission to such programmes are advised to send their applications on the prescribed form along with duplicate Photostat copies of the transcripts to The Director, International Affairs, administrative Building, Shri Krishna University.

101.1.2- The admission of International Students to Medical/Biotechnology and Engineering programmes is privilege of the Ministry of External Affairs, Government of India, New Delhi. A number of seats in these programmes are reserved for the International Students of various countries. International students desirous of joining these professional programmes should contact the nearest Indian Embassy for necessary information.

#### 101.2- INTERNATIONAL STUDENTS

Under UGC Guidelines, 'International Students' will include the following:

101.2.1- Foreign students: Students holding passports issued by any foreign country including people of Indian origin who have acquired the nationality of foreign countries.

101.2.2- Non Resident Indians (NRI): Only those Non Resident Indian students who have studied and passed the qualifying examinations from schools or colleges in foreign countries will be included as International students. This will include the students studying in the schools or colleges situated in foreign countries even if affiliated to the Boards of Secondary Education or Universities located in India, but will not include students studying in those schools or colleges (situated in India) which are affiliated to the Boards of Secondary Education or Universities of the foreign countries. The students passing the qualifying examinations from Boards or Universities located in foreign countries as external students and dependents of NRIs studying in India will not be included as International Students. Entry level status of International Students on entry to the country will be maintained.

# 101.3- <u>DOCUMENTS REQUIRED FOR ADMISSION OF</u> INTERNATIONAL STUDENTS:

- 101.3.1- Visa: All the International Students will require a student Visa endorsed to this University for joining full time courses. No other endorsement is acceptable. Students wishing to join a research programme will require a Research Visa endorsed to this University. The Visa should be valid for the prescribed duration of the course. A visa is not required for NRI students. Students who are doing full time courses, in some other institutions, do not require a separate visa for joining part time courses provided that their current visa is valid for the entire duration of the course.
- 101.3.2- No Objection Certificate: Students are no longer required a No Objection Certificate (NOC) for joining professional courses. (This has been withdrawn by the Government of India vide letter No. F.No.33-17/2002-U.4 dated 20th August 2004.) All International Students wishing to undertake any research work or join a Ph.D. or M. Phil. programme will have to obtain prior security clearance from the Ministry of Home Affairs and the approval of Department of Secondary & Higher Education, Ministry of Human Resource Development, Government of India and this must be on the Research Visa endorsed to this University

#### 101.4- ADMISSION OF INTERNATIONAL STUDENTS:

- 101.4.1- Admission of all the International Students will be done through the University's Office of the International Affairs. The students will generally be admitted in the beginning of the course. However students can also be admitted as transfer cases in the middle of the course from other institutes with which there is an understanding for accepting the students as transfer cases
- 101.4.2- The admission of international Students is done in two stages. First, a student wishing to join the University gets the application form and the information on the eligibility requirements, courses available and admission procedure from the prospectus or the website of the University. The application for provisional admission is then submitted to the International Student's Cell along with the prescribed fees. The Cell will then check the eligibility and issue the provisional admission letter. This is required to get the visa and to complete other formalities
- 101.4.3- After getting provisional admission, the student should get the Student Visa and complete all other formalities. The student should then report for final admission to the University where he wants to join the course. The next step is to fill up the admission form from the concerned institute and pay the required fees. After this, the student should undergo the medical examination. Students are required to pass the English proficiency test if applicable. Once this is done, the final admission is given.
- 101.4.4- The International Students will have to pay the fees in US dollars. In special cases, permission will be given for payment of fees in Indian currency.

#### 101.5- EQUIVALENCE COMMITTEE

101.5.1- On the basis of the recommendations of the Board of Management, SKU has constituted an Equivalence Committee for the verification of Certificate/Degrees of the International Students which shall be comprised of Dean Academics/Chairman Admissions as Chairman, and the Director, International Affairs, Concerned Deans of the Schools and Admission Coordinator as the members of the above mentioned committee. Some special members may also be invited if need arises.

# 101.6- <u>APPLICATION PROCEDURES FOR INTERNATIONAL</u> STUDENTS

Applicants seeking admission to programmes of this University and have passed a recognized examination are advised to send their application form on the prescribed along with duplicate Photostat copies of the transcripts to The Director, International Affairs, Shri Krishna University. International Students are exempted from entrance tests for admission. However, they should pass the equivalent Qualifying Examination from an Indian or any International University / Institution.

- 101.6.1- International students have to follow the following steps for applying for admission in different programmes of Shri Krishna University:
  - 101.6.1.1- For those International Students who are already studying in India or having an Indian degree (for all programmes)
    - Channelize their admission application form routed through their Embassy / High Commission / Consulate in India (for the purpose of verification of their educational qualification viz. mark sheet, degree, etc.)
    - Application form should be routed to University through Embassy / High Commission / Consulate addressed to The Director, International Affairs, Shri Krishna University.
    - The Office of the International Affairs, Shri Krishna University will send the application to Department/School that applicant wants to join (Application must have a three options for their choice of programmes for each candidate.
    - The Director, International Affairs, Shri Krishna University will issue provisional admission latter for applicant when receiving approval letter from concern Department/School.
    - This letter will be sent to the Embassy addressed to the First Secretary (in charge of Science, Technology & Education) which is a provisional admission letter.
    - Then the First Secretary will inform the applicant to take admission in Shri Krishna University in their choice of program.
    - The applicant will come back to their country of domicile for getting visa formalities (Student Visa for Diploma /Graduate/Post-Graduate courses; Research Visa for Ph.D. course).
    - After getting the Student/Research VISA, they can get confirmed admission in their program of choice after paying the University Fee.
    - Admission of International Students will be confirmed only after verification of original certificates, medical fitness test and payment of required fees.
    - Within two weeks of arrival in India register their names with the police in the Foreigner Regional Registration Office (FRRO) of the local Police.
  - 101.6.1.2- For those International Students who are eager to apply from their own country (for all programmes):
    - Channelize their admission application form routed through Indian Embassy! High Commission! Consulate in India (for the purpose of verification of their educational qualification viz. mark sheet, degree, etc.). The rest of the procedures are the same as mentioned above.
    - If the candidate meets the eligibility requirements and is found eligible, University will issue provisional admission letter to him.
    - A copy of the same letter will be endorsed to the concerned Indian Embassy in the country of domicile of the candidate on the basis of which the concerned Embassy

- will issue a Research / Student's Visa so that the student can come to India and join the University.
- No International-Student shall be admitted to this University without Research, Student's Visa. Such Student's Visa will be extended by the Ministry of Home Affairs after ascertaining that student pursuing his studies, is receiving remittance through proper banking channels.
- The admission of International Students to Medical and Engineering programmes is done by the Ministry of External Affairs, Government of India, and New Delhi.
- A number of seats in these programmes are reserved for the nationals of various countries. International Students desirous of joining these professional programmes should contact the nearest Indian Embassy for necessary information.

# 101.7- GENERAL ELIGIBILITY CRITERION FOR INTERNATIONAL STUDENTS:

- 101.7.1- The Degrees/Certificates of the International Students should have been recognized and approved by the Association of Indian Universities (AIU)! Commonwealth Universities! International Association of Universities (IAU) as equivalent to the corresponding Indian Degrees/Certificates.
- 101.7.2- They hold a valid passport from their respective countries.

#### 101.8- ADDITIONAL ELIGIBILITY REQUIREMENTS:

- 101.8.1- A candidate studying in the final year of or having qualified for a Degree in General Course of Study from SKU or any other University/Institution shall be entitled to apply for admission to the next higher course/Degree.
- 101.8.2- If the applicant has passed the qualifying examination where grades are awarded:
- 101.8.3- Where the grade sheet doesn't mention the equivalent percentage of marks from grade points, the candidate should submit a certificate of conversion from the concerned institution mentioning either the converted percentage or the formula for the actual conversion of grade point average to percentage of marks and
- 101.8.4- Where the grade sheet itself mentions the equivalent percentage of marks from the grade points or formula for such conversion, the candidate should get both sides of the Degree/Grade Sheet photocopied showing the equivalent percentage of marks/conversion formula and enclose with the Application Form.

Note: Candidates admitted to any course in this University shall not be eligible to pursue simultaneously any other full time course in this or in an)' other University/Institution.

- 101.9- Eligibility for Admission to Under Graduate Programmes:
- 101.9.1- Evidence of required academic performance must be in the form of certified English transcripts listing all the programmes with the grades or marks earned.
- 101.9.2- Transcripts in languages other than English are not acceptable.
- 101.9.3- Applicants for any of the Under-Graduate Course must have completed the 12 years or 10+2 years of formal schooling.
- 101.9.4- The applicants who have passed final School Certificate Examination of twelve year duration.
- The minimum admission requirement in terms of the percentage of marks that are required by a candidate for being admitted to a course varies in many cases from Course to Course.

#### 101.10- Eligibility for Admission to Post-Graduate Programmes:

101.10.1- For admission to a post-graduate programme of studies in any discipline, one must have completed 12 years or 10+2 years of formal education at the School level followed by a Bachelor's Degree. However, the admission to post-graduate programmes is rather restricted and the applicant with excellent academic records stands a fair chance for admission.

#### 101.11- Eligibility for Admission to M. Phil. and Ph. D. Programmes:

101.11.1- Shri Krishna University also offers M. Phil. and Ph.D. Programmes of concerned Schools(as Per Ordinance 2) The minimum admission requirement for the Research Degree (Ph.D.) is a post graduate degree of two years duration of any Indian University or any other degree recognized as equivalent to it. The admission for these programmes is very limited and is decided by the respective Schools on the basis of a very sound academic record along with a detailed research proposal.

#### 101.12- Age Requirements:

101.12.1- No candidate is qualified for admission to the University in the first year of the degree course unless he is 18 years of age before the first day of October in the year in which he seeks admission. Likewise for post graduate and research programmes the applicant must be 20 years of age before the first day of October in the year in which admission is being sought. However, the Admission Committee may give some relaxation to meritorious students.

#### 101.13- Transfers & Change of Course:

101.13.1- An International Student who has been granted admission to a particular course shall not be allowed to change the course. Transfer from one institution in India to another is also not allowed ordinarily. In exceptional cases, the International Students Cell may permit this, based on the availability of the course, eligibility rules and with the permission of the Competent Authority of the University.

#### 101.14- Government of India Scholars:

101.14.1- International Students who are awarded scholarships by the Indian Council for Cultural Relation, New Delhi shall be given preferential treatment while granting admission and for hostel accommodation. Sponsored candidates from different Foreign Governments for training and studies are also given preference for the same.

#### 101.15- VISA Requirements:

101.15.1- The University shall issue a Bonafide Certificate to the International Student covering all the important information of the student like Name of the student, Gender, Date of Birth, Passport No., VISA No., Name of the programme, etc. for VISA requirements.

#### 101.16- Health or Medical Requirements:

101.16.1- All the International Students required to produce medical fitness certificate. As per government rules all International Students entering India on Student Visa have to be tested for HIV and will not be given admission if found to be positive. All the resident students (National/International) in the University Campus are covered under Health Insurance. For any medical emergencies, the University will facilitate medical aid to students.

#### 101.17- Discipline:

101.17.1- The International Students will abide by all the rules of the University and the code of conduct as applicable to Indian students doing same courses.

#### 101.18- Examination and Award of Degrees & Diplomas:

101.18.1- The procedure for examination, payment of examination fees, issue of mark list, issue of passing certificates and award of degrees will be same as for the Indian students doing same courses.

The above rules will be applicable for admissions done after the issue of these rules. In case there are any differences on the interpretation of rules then the opinion of the Office of the International Affairs in consultation with the competent authority of the University will be final. The fees are liable to revision and students will have to pay the revised fees when applicable. On the points not specifically covered, the decision of the Universities authorities will be final.
